Camau Courses: Growing Bilingual Confidence:

Thanks to Cwlwm's collaboration with the National Centre for Learning Welsh, the Camau self-study courses are thriving across the sector. Cwlwm supported the rollout by actively promoting the courses, inspiring and encouraging sector participation, providing guidance to learners, and helping embed Welsh language learning into workforce development. Cwlwm is playing a key role in contributing to the delivery of the Cymraeg 2050 vision by creating a more confident, bilingual workforce for the future.

Expanding Welsh Language Provision: The Welsh Promise • CYMell • Plethu Scheme

The Welsh Promise:

Developed, coordinated, and promoted by Cwlwm, the scheme has seen growing interest and engagement across the sector. Settings have worked towards bronze, silver, or gold recognition, drawing on the valuable support provided by Cwlwm to help meet the requirements of the 'Active Offer'. The continued uptake of the Welsh Promise reflects a consistent commitment to encouraging bilingual practice across the sector.

2024–25 Progress:

Learners engaged strongly with the awards, with

12 achieving Gold, 25 achieving Silver, and

74 achieving Bronze – reflecting significant skill

development across the sector.

CYMell:

Funded by Welsh Government, CYMell supports the growth and sustainability of Welsh-medium and bilingual Out of School Childcare across Wales

- Tackling the shortage of CIW-registered Welsh-language provision
- Increasing Welsh use beyond the classroom
- Supporting Cymraeg 2050

CYMell Achievements:

- CIW Registration Support 16 settings achieved registration/expanded to provide Out of School Childcare (26 Project to Date (PTD)), with 26 registration grants (£1,000) awarded (47 PTD)
- 4 Sustainability Grants awarded (£2,500)
- Playwork Training funded & bilingual 98 qualifications achieved (186 PTD),
 71 bursaries paid allowing settings to pay staff to attend training (176 PTD)
- 3 Language Transition Grants awarded (£4000): 1 setting has changed its operational language to Welsh (3 PTD)

Plethu Scheme:

Cwlwm supports childcare and playwork providers to stay financially secure, access funding, and strengthen long-term sustainability.

How We Do This:

Grant Promotion & Support

- Identify and share various funding opportunities with providers e.g BBC Children in Need, Asda Foundation, Moondance Foundation, National Lottery Awards for All, Co-op Community Fund, Tesco Stronger Starts, Screwfix Foundation, Community Chest Funding, Local Authority Capital & Sustainability Grants.
- Identify and access funding as umbrella organisations to support the sector e.g. Moondance Foundation Assisted Places, National Lottery Fund to support improved sustainability and delivery of funding, financial planning, marketing, and supporting registration with Care Inspectorate Wales, Tax-free Childcare, and the Childcare Offer.

- Support Local Authorities with approvals of grants through panel meetings and promote Local Authority grants to members.
- Encourage providers to apply for relevant grants and funding sources.
- Provide necessary support and guidance throughout the grant application process.
- Build provider confidence in administering and managing grant funds.
- Support efforts to improve sustainability, staffing, quality of care, and resources through effective grant use.
- Understand the state of the sector in terms of financial sustainability through surveys and provide bespoke and strategic support.

Practical Financial Support

- Delivered business health checks, helping members identify risks and create action plans for improvement.
- Provided business plan templates to help providers strengthen and manages their settings with confidence.
- Empowered treasurers with a clear, easy-to-use funding guide available online.
- Encouraged settings to promote financial support to parents through resources.
- Supported settings with marketing skills, blogs and toolkits.
- Guided committees through funding changes, rising wage costs & sustainability planning.

- Equipped providers with cash flow tools and timely grant alerts to support decision-making.
- Helped settings stay compliant with expert 1:1 support for Charity Commission accounts.
- Built confidence in reporting with training on annual reports and financial returns.
- Signposted providers to Business Wales for support in developing business plans required for some local authority grant applications.
- Partnered with Business Wales to deliver 3
 bite-size webinars Legal Status & Compliance,
 Marketing & Growing Your Business, Tendering
 & Pledges, supporting providers to grow, adapt,
 and prepare for Flying Start, Early Education, or
 business development.

Supporting Welsh Government with the Childcare Offer

- Shares updates through newsletters, social media, and direct communications.
- Actively promotes Welsh Government surveys e.g Income and Expenditure for Childcare Providers.
- Feeds sector views, calling for clearer guidance on permissible charges under the Childcare Offer.
- Engages providers through forums, Q&A sessions, and webinars.
- Signposts settings to relevant guidance, eligibility tools, and application support.
- Promotes real stories and case studies to highlight benefits of the offer.

Supporting Welsh Government with Legislative Developments:

Cwlwm supports Welsh Government with legislative developments by providing sector insight, evidence, and coordinated responses to ensure that policy and regulatory changes reflect the needs of childcare, play, and early years providers across Wales.

National Minimum Standards (NMS)

- Provided collaborative input into the NMS review, ensuring that it reflects the realities of childcare and playwork settings.
- Participated in key advisory groups (e.g. ratios, qualifications, structure).
- Supported sector understanding through guidance, newsletters, and training.
- Gathered feedback from providers and shared insights with Welsh Government.



Child Minding and Day Care Exceptions (Wales) Order 2010

- Provided collaborative input to the Exceptions Order by challenging and testing proposals, highlighting potential unintended consequences, shaping questions for public consultation and considering a Voluntary Approval Scheme (and other models) for providers of childcare, play and activities.
- Advised Welsh Government through active participation in advisory groups, attending meetings and providing feedback on key documents including options for voluntary approval scheme.
- Supported Welsh Government by sharing insights on how the Exceptions Order and NMS work in practice, helping inform the review and potential changes.

Ministerial Review of Play

- Actively engaged in the Ministerial Review of Play, advocating for play to be embedded across all early years settings.
- Ensured that playwork principles were considered in the broader ECPLC context.
- Highlighted the importance of inclusive and accessible play opportunities across different communities, and the link between play, learning and childcare.



Independent Review of Childminding

- Supported Welsh Government in taking forward recommendations from the review.
- Continued to highlight the challenges of recruitment, retention and registration and push for key areas of development needed to ensure positive impact.
- Worked to support the development of an action plan to take work forward.
- Worked collaboratively with key partners and stakeholders.

Other Relevant Legislative and Policy Contributions

- Promoted alignment between Flying Start, Foundation Learning, and childcare by encouraging a joined up funded system.
- Supported Welsh Government's ECPLC policy framework through sector events and regular updates to raise awareness.
- Workforce development and qualifications engaged in the reform of Level 2–5 qualifications to ensure accessibility, quality and bilingual delivery, and has contributed to shaping the All-Wales Workforce Development Plan.
- Equality and Inclusion advocated for policies that reduce barriers to access for minority ethnic communities, disabled children, and those in poverty and supported work around antiracist Wales and inclusivity in childcare.
- Welsh Language Promotion Embedded Welsh language goals into legislative and policy discussions and promoted pathways for Welsh-medium childcare and play settings, helping Welsh Government meet Cymraeg 2050 goals.
